# **OR Area Director**

Oregon Area Report Jan-March\_ 2015

The competition year is just getting started in the Pacific Northwest. The first qualifier of the year is May 29-31 at Sanderson Field in Shelton, WA. This new event replaces the qualifier previously held in Snohomish, WA.

With the beginning of the new competition year I wanted to help make everyone aware of a new score sheet option and flight judging feedback symbols. I have made a post on the USSMA website in the Forums. A copy of the optional score sheet is also included in the 2015 Competition Guide. It's very important to note that this is a change to the score sheet only. It does not change any of the scoring content/criteria for maneuvers 1 - 9 or maneuver 10 Overall Flight Realism. Also, it is an OPTION....no one has to use it if they prefer the traditional score sheet. It is intended to help judges provide better feedback to pilots and for pilots to better understand the scoring content. I also hope it might help judges to more accurately score a maneuver and aid in consistency between judges. (Ed. Note: The score sheet and feedback symbols can be found at LINK).

For each flight maneuver the score sheet has a column for Precision, Placement, and Realism, and Options, Power, and COF for Overall Flight Realism.

The score sheet could be used in different ways. For Flight Maneuvers 1-9:

- 1. The component columns could be totally ignored and a judge could just put in a total score for the maneuver. (Definitely not the preferred method).
- 2. A judge makes a tick mark (in real time) in a specific column for each 1/2 pt downgrade. Again, that's done in real time so there's no trying to remember something later. The total maneuver score is 10 minus 0.5 X the number of tick marks. This could be very fast and it would certainly give a good indication for cause of a downgrade. The total maneuver score could be calculated after the flight.
- 3. A judge enters the total maneuver score and puts symbols or comments into the appropriate columns for any downgrade. I think this would be great feedback to the contestant and make the judge think more about what is being downgraded and how he/she arrived at the score. It could also aid in helping a judge to be more consistent. This score sheet has much more space to insert symbols than the traditional score sheet. Revised/updated symbols for different judging elements that go into Precision, Placement, Realism....and Options, Power,

# **Finance Director**

The current balance in the USSMA checking account is \$17,539.88, but \$1,000.00 of that amount is to be applied to the 2015 Championships (thank you Gary Norton). So effectively, our general account balance is \$16,539.88. So we are holding steady and fluctuating between \$16,000.00 and \$17,000.00. I would still like to see some definite movement upwards to \$20,000.00, but it will take more time.

Usually, the Championships is an opportunity to bank some profit, not guaranteed, but a chance. However, this will not be the case for the 2014 Championships. In my last treasurer's report, I reported that the discussions between USSMA and ORVRCF were not final, but I was hopeful that our profit would be around \$935.02. Unfortunately, due to an impasse, we will instead have a loss of \$423.35. Here is what happened.

In January of 2014, Curtis brought up the idea of placing ads in Model Aviation and possibly other RC magazines advertising the 2014 Championships. I was agreeable as long as the expense was a Championship event expense (used as a cost of the event before the overall profit for the event was calculated). We had an ad designed.

Curtis was communicating USSMA's intent to place these ads with ORVRCF as things developed early in the process, including the following email communication before the contract was signed:

Continuity would be provided to judges and contestants for reference. These would be on a sheet separate from the score sheet so the symbols are not lost as the scores for each round are torn from the sheet.

For Maneuver 10 Overall Flight Realism:

The competition guide is quite specific that scoring for Overall Flight Realism is for "how well the aircraft maintains a general realistic appearance on the ground and in the air before, between, or after selected maneuvers." Section 9.10 Flight Realism and Score Sheet Review in the Guide says: "After the flight has concluded, the flight judges shall confer to review the numerous Overall Flight Realism qualities as described in this Guide. Identical flight realism scoring is not required. Individual judgment scores will still be of value for statistical averaging similar to others. Any zero scores given for any maneuver shall be mutually agreed upon by both flight judges and both will give identical scores of zero."

This is also the time to review any automatic downgrades. List of Automatic Downgrades are as follows:

- a). No Retracts. If the model does not have retractable gear when the full size did, then deduct 4 points from the Overall Flight Realism score.
- b). No Flaps. If the model does not have or the pilot does not use flaps during the flight where applicable, deduct 2 points from the Overall Flight Realism score.
- d) No Pilot Figure. A pilot figure must be visible during flight (if the full size was visible) or the score will be downgraded by 2 points for Overall Flight Realism.

I will be requesting the judges at my Qualifier in July to use and evaluate the new score sheet and flight symbols. I hope others will either precede or follow with an evaluation also.

The ad will run in the AMA magazine and on the web version of the magazine, we are looking at May to August for the magazine with the web version possibly 5 months long this add will be a little different. I will again work with the AMA to have a rep. at the event to do an article on the Champs. Let me know what you think about what was done for us with the 2013 Champs, video, article and Dist. 10 website. I will put the Best of's list together and attach it to the 2014 Champs list when that is put together. Thank You for steeping up as the host club.

So I modified the contract to including the following paragraph to be consistent with the objective of placing magazine ads, and the contract was signed by ORVRCF on 3/16/14.

"20. Both USSMA and ORVRCF may arrange for magazine ads for the event in various model aviation publications per the approved budget."

USSMA paid AMA the amount of \$336.74 for the ads on 3/27/14, 5/27/14, 6/26/14 and 8/4/14 and \$351.00 on 6/27/14 for one Fly RC ad, total \$1,697.96. But after the 2014 Championship event, when the numbers were being shared, ORVRCF took the position that the magazine ads should not be an event expense.

With the magazine ads included as a championship event expense, the total profit would be \$4,675.10 (\$935.02 (20%) for USSMA & \$3,740.08 (80%) to ORVRCF). However, excluding the magazine ads as a championship expense, the total profit would be \$6,373.06 (\$1,274.61 (20%) for USSMA & \$5,098.44 (80%) to ORVRCF). But from USSMA's profit of \$1,274.61, we need to subtract the magazine ads of \$1,697.96, leading to a USSMA loss of \$423.35.

Obviously as your Treasurer, watching every dollar, I am disappointed with this outcome, but the USSMA board of directors decided to not pursue the issue further.

So now I will look to the future and to the 2015 Championships. I am excited about having the Championships in Texas (more central location) and hope that it will attract many more contestants. We are at the point of looking for raffle prizes, best of sponsorships, and general sponsorships for the event, as well as commitments of contestants to compete as the event. So until next time.
